**Subject: REACH regulation – (EC) 1907/2006, Information to the update of the SVHC Candidate list from November 7<sup>th</sup>, 2024**

Dear Customer,

With regard to the latest update of the SVHC Candidate list on November 7<sup>th</sup>, 2024 we would like to inform you on NEVEON Austria GmbH's status and its ongoing activities in respect of the applicable European Chemical legislation.

As you know, NEVEON Austria GmbH itself is considered as a downstream user (i.e. a producer of Polyurethane Articles) and in consequence does not fall under the obligation of registration which is an obligation for our suppliers. Nevertheless, NEVEON Austria GmbH is regularly communicating with its suppliers and follows all relevant discussions within ECHA to ensure that NEVEON Austria GmbH would only use REACH compliant products for its business activities.

Based on the information available to us, we can inform you that the articles supplied to you by NEVEON Austria GmbH do not contain any of the SVHC's as listed until today in the Candidate List above a limit of 0.1 % (w/w), except that some of our products are containing Melamine in a concentration above 0,1% (w/w).

Melamine (CAS 108-78-1) was included as SVHC substance in the SVHC candidate list on January 17<sup>th</sup>, 2023. If your products were affected, you have been informed in a separate letter with reference to Article 33 (1) REACH about the Safe use of Melamine. NEVEON Austria GmbH has also submitted a notification in the ECHA SCIP database according to the Waste Framework Directive about their articles containing Melamine in a concentration above 0,1% (w/w).

For the articles and packaging materials purchased by NEVEON Austria GmbH as of today, none of the suppliers of these articles has announced that its products contain SVHC ingredients or SVHC's above 0.1 % (w/w).


